### **Mental Health Issues on** the Ballot

Our current 114th Congress will vote on the Congressional Bill Helping Families in Mental Health Crisis Act. Early September, there was much to be celebrated as the House of Representatives voted nearly unanimously to pass this bill, HR2646, for voting at the federal Congressional level.

Unfortunately, change like this is all too often inspired by tragedy. Revised in 2015, this current bill builds on a 2013 initiative introduced by Pennsylvania Congressman Tim Murphy and Texas Representative Eddie Bernice Johnson. Tim Murphy's background is in psychology. His response to the tragic 2012 Sandy Hook Elementary School shooting inspired what is now referred to The Helping Families in Mental Health Crisis Act, or HR2646. A couple or points in the proposal include increasing Medicare funding for Mental Health reimbursement or eliminating the 190 day lifetime cap, and reducing the national deficit of more than 100,000 inpatient psychiatric beds. In California, Prop 61 State Prescription Drug Purchases, Pricing Standards Initiative Statute has the attention of both the California Nurses Association and numerous Pharmaceutical Companies.
