## **Meeting Report of Florida Coalition of Advanced Practice Nurses**

Quarterly Meeting: October 11, 2014

Location: University of Miami School of Nursing and Health Studies | Coral Gables, Florida

Created in 2007 to promote the health and access to health care for all Floridians, the members of the Florida Coalition of Advanced Practice Nurses group represent the wide variety of advanced practice nurses licensed to practice in Florida. Member organizations include FANA, FCNM, FNA, FNPN, FLANP, Action Coalition, AANP, the Deans and Directors Group and APNA. All organizations focus advocacy efforts on the creation of models of healthcare and legislative changes that would allow Advanced Practice Nurses to utilize their expertise to the full extent of their education and training.

Carole Kain, as a representative of the Florida Chapter of APNA, attended the organization's quarterly meeting, held in October, at the University of Miami. This meeting served as a review of the recent legislative session and the hurdles that the bill introduced by Representative Cary Pigman in the House encountered. Additionally it was a forum for discussions about organizational collaborative strategies that will be used to educate legislators about the advantages of using Advanced Practice Nurses in healthcare. There is interest in the creation of coordinated physical presence and educational efforts of the upcoming legislative session. With the goal of maintaining a unified voice or message in all contacts with state legislators, use of the newly created PowerPoint slide presentation for members was encouraged. Each group shared individual organizational plans and efforts to energize grassroots membership of their organizations to be more visible and vocal about APN practice and Florida health issues. The challenge of educating newly elected legislators is large and all nurses and advanced practice nurses are needed to achieve our goals. Mai Kung is also acting as the coordinator of the organization efforts.

The next quarterly meeting is scheduled in Orlando at FNA headquarters on January 17, 2015. An APNA representative will attend.

#### LEGISLATIVE NEWS YOU CAN USE

How involved were you in the elections? Or like many of us, were the pressures of work, home, children, or school to overwhelming for you to volunteer to support your favorite candidate? Do you even know who the House of Representative or Senator for your district is? Have you met him or her? Do you know where they stand on your issues?

Before you turn the page and move on to other things, ask yourself:

- Did all Registered Nurses, Clinical Specialists, and Advanced Practice Nurses gain the ability to practice to the full extent of their education and experience?
- Is your hospital using a collaborative council to assure safe staffing patterns and protect you on each hospital unit?
- Have there been legislative efforts to strengthen the public health system and improve access to care or promote healthy lifestyles for Florida citizens?

Yes, the nasty TV ads and unceasing telephone solicitations have stopped but your support for your profession, yourself, your colleagues and your patients is still needed. Let's work together to learn how to be informed educators about the issues. Advocacy takes time and effort and does not become successful overnight. Most importantly, advocacy should not happen only during legislative session. The place to start is your own backyard. There is greater impact meeting with your legislators while they are at home in their district offices than when they are in Tallahassee. You have a greater opportunity to express your concerns and to talk with them about the effects their decisions had on your community.

**Step 1**. Identify your legislative representatives. How?

Go to <u>www.flsenate.gov</u> and <u>www.myfloridahouse.gov</u> and enter your ZIP code.

- OR Check your voter registration card.
- **Step 2.** Google your representative or senator and identify the phone number of their local office and make an appointment for a brief visit. Introduce yourself and share your knowledge about what you know best--- nursing.

## **Submission of Abstracts**

#### **Guidelines and Information**

Abstracts are limited to 250 words or less.

Abstract Guidelines: Abstracts must contain the following information:

- Poster-Title
- Author(s)-Names and e-mail addresses
- Keywords-Identify the keywords applicable to the submission
- Brief content description:

List citations for evidence used (must have at least 1); provide the purpose statement for the presentation; identify the gap area to be addressed (knowledge, skill, practice, or other); provide a description of the current gap; and provide a description of the desired/achievable state.

Poster Abstract: See guidelines. Please limit your abstract to 250 words or less. Use additional sheet if necessary. If you are not using Microsoft word, please save your file in rich text format [rtf] prior to submission.

## **Poster Guidelines**

Posters should be self-explanatory and convey content in a clear, concise fashion.

Posters will be displayed as power point 3 ft. by 4 ft. or larger posters that can be attached to a wall or vertical surface.

#### **Best Practice Content:**

- Title and Authors: Place the poster title and names of authors at the top center of the poster. The title should be legible from 10 feet.
- Introduction: Give a brief background and then state the purpose of your practice intervention or program.
- Practice Description: Provide a description of your selected best practice.
- Include appropriate graphics/pictures. Include evaluation information if available.

#### **Research Content:**

- Title and Authors: Place the poster title and name(s) foundation of author(s) at the top center of the poster. The title should be legible from 10 feet.
- Introduction: Give a brief background/, and then state the purpose of your research as either a question or hypothesis.
- Methods: Brief description of the techniques, data collection, replicas, and statistics you used. Omit unnecessary detail.
- Results: Include tables and graphs that are easy to read and understand.
- Conclusions: What did you find out? Did you accept or reject your hypothesis?
- Describe your results in general terms. What is the significance of the findings?

#### **Review criteria for Abstracts:**

All poster submissions will undergo blind, peer review. Acceptance will be based on scoring in areas of relevance of content, quality of the abstract, originality and innovation of content to be presented, and feasibility for replication or implementation.
